The confirmation of internship shall contain information about the areas where the trainee acquired technical and language skills, the social skills acquired and the methods of evaluating the learning outcome.

5. Application of Austrian Law:

The company offering the internship training abroad will observe Austrian working and social regulations. In particular, it will respect the Austrian Act on Child and Adolescence Labour (Kinder- und Jugendlichen-Beschäftigungsgesetz) as well as the Decree banning employment of children and adolescents (KJBG-VO).

The company offering internship training abroad will educate the apprentice to its best ability and will convey all identified training content to the apprentice. Employment of an apprentice beyond this contract is prohibited.

6. Data protection:

I agree that my data may be shared with third parties in connection with my internship abroad (e.g. with the partner organization abroad, funding agencies) solely for the purpose of organizing and funding my language course and my internship abroad. I further agree that my data may be stored in national and EU databases for the purpose of verifying and demonstrating the proper and appropriate use of the funding provided. My data will be deleted after the deadlines set by the respective funding agencies and funding programs have expired.
